
Attach attested photocopies of the following documents with the application form in the following sequence:

- Twelve (12) Passport size coloured photographs of the applicant attested on the back.
- Four copies of detailed Marks Certificate of examination and Degrees on the basis of which admission is sought (KMU-CAT result card, Domicile, SSC,F.Sc or equivalent, Original Migration Certificate from Board to University and all relevant).
- Equivalence certificate from the Inter-Board Committee of Chairmen if the qualifying certificate is from an Institute abroad.
- Domicile certificate once submitted with the application form will not be changed.
- Four Copies of Computerized National Identity Card of the candidate or Computerized Form B, copied on Full size paper
- Four copies of computerized National Identity Card of the father of the applicant copied on Full size paper, if the father is not alive, then provide copies of the National Identity Card of the mother & guardian.
- Four copies of attempt certificate from the concerned BISE, if the period between SSC and F.Sc is more than two sessions.
- Undertaking on judicial stamp paper of Rs. 100/- duly attested by notary public /Political Agent as per specimen given in the prospectus/admission (*only after getting admission*).
- For B.Sc. Post RN Candidates: Four** Copies of all diplomas along with DMCs (in General Nursing & Midwifery or any Specialty) duly attested by the respective Examination Board, copy of valid PNC Registration and valid experience certificates.

IMPORTANT NOTES/INSTRUCTIONS

1. All applicants must appropriately fill and sign the admission form and undertaking. **Incomplete/not properly filled form in any respect will be rejected.** Avoid rewriting/cutting, while filling the form.
2. The undertaking/agreement must be filled in by the candidate on Judicial Bond of Rs. 100/- and should be duly attested by the Political Agent/First Class Magistrate. The specimen Performa for undertaking is attached with the application form.
3. Applicant must carefully study the Admission Policy of Khyber Medical University and HEC Policies in order to understand the Rules.
4. The domicile, DMC of F.Sc. (Pre-Medical)/Equivalent Examination, SSC and other certificates once submitted with the admission form cannot be changed and shall be considered as final. Revision of result or improvement of marks by the board/IBCC after the finalization of merit list shall not affect the merit list of admission of current year in any way.
5. Application forms with any **false statement** by the candidate will be rejected
6. If any certificate submitted by the candidate is found **false, or forged** during his/her **study period** his/her admission shall be cancelled forthwith and he/she shall be **blacklisted** for admission to any professional colleges in Khyber Pakhtunkhwa. Further legal action can be taken against the student under the existing criminal laws.
7. Application form shall be submitted on due date to the office of **Principal/Director of the concerned institutions**
